2. Personal data processed by SFSA

SFSA processes* personal data of members of SFSA. The purpose of each category of personal data is listed in section 3.

*According to the law, the collection, recording, arrangement, storage, updating, modification, retrieval, consultation, use, transmission, distribution, making available, combining, linking, blocking, erasure and destruction of data are included in the 'processing' of personal data.

Below is an overview of all the personal data we process:

- 1. First and last name
- 2. Student number
- 3. E-mail address
- 4. Photos

3. Processing objectives per data category

- First name and surname are processed by SFSA for the identification of members. After unsubscribing, this data is kept for the archive of former members for alumni events and any anniversaries. If you would like your data to be deleted, please contact us, and we will delete it within a month.
- Student numbers are processed by SFSA to check whether the members are studying at the institution they've filled in. In order to be able to make a claim to the UvA's profiling fund, it has to be possible to check how many members are studying at the UvA.
- E-mail addresses are processed by SFSA so that members can be kept informed about the events of SFSA, such as documentary evenings, activities, workshops and so on.
- 4) Photographs taken at SFSA events may be published on the Facebook page, Instagram page or website of SFSA to be used for promotion for future events. If there is a picture that you are standing on and you do not want to share this picture

on the internet, you can send an email to <u>voorzitter@sfsa.nl</u> and this picture will be removed. SFSA may use the photos for the promotion of subsequent events, workshops or other activities or for use on the site or Facebook. Photos of members must be removed from Facebook and other platforms that are being used within one month at the request of the member in question.

4. Incidental data processing

In addition to the data mentioned above, we also process incidental data for events or workshops organised by SFSA. The kind of data depends on the event in question. Personal data obtained for an event will not be used for any other purpose than the organisation of this event. After an event or trip, SFSA will delete the data of members who are not going to be used for any other purpose within a month.

5. Security of your personal data

SFSA takes the protection of your personal data seriously. We, therefore, take the following precautions.

1. Access to and misuse of your personal data

Personal data that SFSA preserves for a longer period of time will be stored on Google Drive. Only board members have access to this. In the SFSA processing register, you can read who processes this data and which systems are involved. Commission members have access to incidental personal data of the event that the Commission is organizing. The committee members have been informed of SFSA's privacy policy.

2. Sharing of personal data with third parties

The Board of SFSA reserves the right to share personal data with third parties. Should this situation arise, a well-considered assessment will be made by the board of SFSA per personal data and per third party, whereby your privacy will be treated with the utmost care. For third parties, you can think of the University of Amsterdam. However, we will never use your personal data for commercial purposes.

3. Security measures

The use of personal data on paper will be avoided as much as possible. Personal data that are kept on paper for a longer period of time are kept in a locked safe, to which only board members have access. In the event of a data breach, this shall be recorded in the data breach register and action shall be taken as indicated in the 'Protocol data breach of the SFSA'.

4. Removal of/ viewing personal data

You always have the right to view and remove your personal data that we have collected. You can always, at any time, decide that we have to delete your data. To do so, send an email to <u>voorzitter@sfsa.nl</u>, in which we have a month to fulfill your request. If you

request the removal of name, surname, email address and/or student number, you can no longer be a member of SFSA. Without a student number, you can still be an SFSA alumni.

We do not have any automated systems for the processing of personal data. Decisions about personal data are made by the board.
